**January 26: “Progress in Women’s Leadership from the C-Suite to the Boardroom: Advocacy, Inspiration and Connections”** featuring **Sarah Ernst, Partner at Alston & Bird and 2016-2017 President of OnBoard.** Sarah concentrates her practice on public and private company securities offerings, mergers and acquisitions, and corporate governance, with an emphasis in the health care sector. Ms. Ernst was named one of Law360’s “Top Attorneys Under 40” and is listed as a Rising Star by Super Lawyers. Beyond her legal expertise and accomplishments, Sarah is passionate about increasing the number of women on corporate boards and in the c-suite, through her work on the Board of Directors and as the immediate past President of OnBoard. She received her J.D. from the Univ. of Oklahoma and her B.S.F.S., cum laude, from the Georgetown School of Foreign Service, and she also attended the U.S. Naval Academy.

**February 23: “Successful Women Don’t Run from Change: They Run Toward It”** featuring **Dagmar Boggs, President of The Coca-Cola Company 7-Eleven Global Customer Team.** In her 22-year tenure at Coke, Dagmar has had numerous leadership positions, including VP of the global Burger King Customer Team, spanning over 90 countries. Previously she worked for the Quaker Oats Co. Among her many other leadership roles, Dagmar serves on the board of the Network of Executive Women (NEW); is a member of the Women’s Foodservice Forum; a “Leader in Residence” at Emory’s Goizueta Business School, and she is a member of Executive Women of Goizueta. Dagmar is also a member of Ribbons of Hope, an Atlanta charity for women. She is a graduate of Rollins College and has an EMBA from Emory’s Goizueta Business School.

**March 23: “Intercultural Business Agility”** featuring **Soumaya Khalifa, CEO / Founder of Khalifa Consulting.** Soumaya’s work across cultures has earned her widespread recognition including an invitation to the White House; being named a Citizen Diplomat by the U.S. State Department; and appearing on TV & radio and featured in the New York Times. She has over 20 years’ experience with Fortune 100 companies, government and non-profit organizations; is Adjunct Faculty at Emory Univ. for Continuing Education; and has served at the Federal Executive Institute to assess and develop top talent. Soumaya holds an MBA in Human Resources from Georgia State Univ.; a B.S. in Chemistry from the Univ. of Houston; and she is fluent in English and Arabic and studied 3 other languages. She is also a contributing author for the book *Religious Diversity at Work*.

She left Delta to accept an appointment as Chief Presiding Judge of the Fulton County Juvenile Court, one of the largest systems in the country. She is also a member of the Atlanta Falcon’s Board of Advisors.

**July 27: “How to Build a Legacy Not Just a Resume” featuring Tom Darrow, Founder & Principal of Talent Connections, LLC and Career Spa, LLC.** With 30 years in the Human Resources and Recruitment profession, Tom has done it all. Nationally and internationally recognized and honored, he has served on the SHRM Foundation Board since 2010, and was Board Chair 2015-2016. Prior to that, he was president of SHRM-ATL '06 -'07, received a Lifetime Achievement Award, and was the GA State Council's HR Leader of the Year. Tom also founded and chaired TAG's Recruiting Society, and was the Inaugural President of TAG's Leadership Council. Equally notable, his community leadership roles, board service and contributions are exceptional.
